From: "If the State terminates this Contract for cause, it will be entitled to cover for the Project by using another Contractor on such commercially reasonable terms as it and the covering contractor may agree. The Contractor will be liable to the State for all costs related to covering for the Project to the extent that such costs, when combined with payments already made to the Contractor for the Project before termination, exceed the costs that the State would have incurred under this Contract. The Contractor will also be liable for any other direct damages resulting from its breach of this contract or other action leading to termination for cause."

To: "If the State terminates this Contract for cause, it will be entitled to pursue all available legal remedies not otherwise limited by the terms of this agreement."

COST SUMMARY:

Offeror must also include a capitated rate, which will be used to make adjustments to the quoted cost per month should the population deviate by more/less than seventy-five (75) inmates. The monthly population will be determined by the inmate count on the last day of each month. The capitated rate will not be used for proposal evaluation.
