APPENDIX 1 (Continued) – MEASURING AND TROUSER LAUNDERING INSTRUCTIONS AND SIZE CHARTS

TROUSER LAUNDERING/CLEANING INSTRUCTIONS – TACT SQUAD T7004BK AND TW7004BK STREET LEGAL CARGO POCKET TROUSERS:

These garments may be dry cleaned or machine washed.

If machine washed, for best garment performance in terms of wear, shrinkage, fading and button integrity, these garments should be washed in COLD water and tumble dried in LOW heat and in a cool/air dry cycle. Bleach or laundry detergents containing bleach and fabric softener should not be used. Garments should be removed from the dryer and folded as soon as drying is completed to avoid undue wrinkling.
