SCOPE

The Contractor shall provide all supervision, labor and materials required to plan schedule, and coordinate the surveys for the Ohio Department of Development, Office of Budget and Finance (OBF). The Contractor will survey Home Weatherization Assistance Program participants by telephone in order to collect outcome and program data. Estimated contract volume is 5,000 calls; 4500 in year one (1) and 500 in year two (2). The cost per call is \$2.00. All work shall be performed to the specifications, unless otherwise stated by representatives of OBF.
