SPECIAL TERMS AND CONDITIONS

CONTRACT TERM: This Contract will become effective April 20, 2015 for the State of Ohio and will expire on June 30, 2015, with the option for this contract to be renewed as set forth with the State of Rhode Island, Master Agreement Number 3400563.

PARTICIPATING ADDENDUM: Contractor shall enter into a Memorandum of Understanding which shall set forth the specific State of Ohio terms and conditions to which Contractor shall agree to abide.

CONTRACT ORDER: Orders are to be placed directly with the Contractor. It is expected that the Contractor will commence Work upon receipt of a state issued purchase order.

SPECIFICATIONS

I. SCOPE: The work and activities of Contractor are set forth in the Program Management Support Contractor Agreement between the Rhode Island Department of Education and PARCC, Inc. dated September 19, 2014 ("Rhode Island Contract").

II. PRICING/PAYMENT TERMS/COMPENSTION

A. Monthly payments will be paid to the Contractor after deliverables and services have been met for that month. Payments will be based on a percentage of the total annual contract value.

For Contract Year 1 only, the Contractor will have met all deliverables per the State of Rhode Island Master Agreement 3400563 payment schedule milestone descriptions for the months of October, 2014 – April, 2015; therefore, payment schedule for April, 2015 will be billed at 80% of the Total Annual Contract Value. Remaining monthly invoices for this contract will follow the State of Rhode Island Master Agreement Payment Schedule.

B. The payment schedule as found in Section 3.2 of the Rhode Island contract has been updated to reflect a April 2015 contract Effective Date. The April start does not reduce the annual deliverables to the State of Ohio.
