

## NOTICE TO BIDDERS

The WORK in accordance with the CONTRACT DOCUMENTS, and any addenda thereto, involves the following:

Provide and install street lighting poles, luminaires, foundations, flexible conduit, conductor, and appurtenant items. The work also includes the removal of the existing street lighting poles, luminaires, and foundations.

The ENGINEER'S ESTIMATE for this project is \$900,000.00.

All bids must be accompanied by a Bid Guaranty or a Certified Cashier's Check or Letter of Credit. The amount of the Bid Guaranty/Certified Cashier's Check/Letter of Credit shall be ten percent (10%) of the bid plus all add alternates.

If the BID is accepted, a Contract must be executed and a satisfactory Performance/Payment Bond furnished, conditioned according to law in the amount of one hundred percent (100%) of the Contract price, within ten (10) days after notice of acceptance. Sureties on all bonds must be satisfactory to the City.

The PROJECT is subject to Chapter 4115 of the Ohio Revised Code regarding Prevailing Rates of Wages.

No BIDDER may withdraw their BID for a period of 60 days after the actual date of the opening thereof. The City reserves the right to reject any or all BIDS.
