AMENDMENTS TO CONTRACT TERMS AND CONDITIONS: The following Amendments to the Contract Terms and Conditions do hereby become a part hereof. In the event that an amendment conflicts with the Contract Terms and Conditions, the Amendment will prevail.

DELIVERY AND ACCEPTANCE: Purchase orders for any item(s) listed in a contract awarded pursuant to this bid will be placed directly with the successful contractor by the using agency. Product will be processed and delivered within one (1) month of receipt of the commodity order or as mutually agreed by the contractor and the Ohio Department of Education (ODE) and, in accordance with Article S-2, S8, S9 and S10 of the Supplemental Contract Terms and Conditions. Deliveries shall be made to the following Ohio sites. The delivery location will be noted on the purchase order issued by the participating agency. All shipments are to be in accordance with the quantities ordered. Quantities ordered may be to the nearest whole pallet, or as mutually agreed by the contractor and ODE. Unloading of ordered product is by appointment only. The contractor shall contact the cold storage facilities to make an appointment for unloading prior to loading for shipment. The percentage of total product to be delivered to each location is also provided. The state reserves the right to add, delete, or change distribution centers and/or percentage of usage during the course of the contract. Acceptance (transfer of title) will occur upon the inspection and written confirmation by the ordering agency that the supplies delivered conform to the requirements set forth in the Contract. Unless otherwise provided in the Contract, acceptance shall be conclusive except in regards to latent defects, fraud, or such gross mistakes as amount to fraud.

TRANSPORTATION CHARGES: Any item(s) ordered from a contract awarded pursuant to this bid shall be shipped F.O.B. destination, freight prepaid to the three (3) cold storage facilities in the state of Ohio listed above, or any other cold storage facilities that ODE designates in the state of Ohio. Commodity will be delivered to the contractor by the USDA, F.O.B. Destination.

PAYMENT: Shall be in accordance with Article III.B. of Contract Terms and Conditions with the following exception: Payments will be due on the 90th calendar day rather than the 30th calendar day. If payment terms are listed on the invoice of the Ohio Department of Education, it must be consistent with the terms of the contract.

DOCUMENTATION

1. The bidder should submit a narrative of their processing and fabrication procedures as part of the bid response for product to be produced under this contract. The processing and fabrication procedures are to describe the product and the exact method of processing.
2. Commodity Food Processing Agreement: The successful contractor shall complete and sign an Ohio processing agreement prior to the inception date of any ensuing contract. The processing agreement will be provided by the Department of Education (ODE), Office for Child Nutrition (OCN) and is the authority to process USDA commodity foods and adherence to its contents is mandatory. Failure to complete and return this document prior to inception date of any ensuing contract may result in immediate cancellation from contract.

Attachment A to the bid, page 13, of the processing agreement is 'Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion – Lower Tier Covered Transactions' (Form AD-10-48 [11/97]). This page of the agreement only should be submitted as part of the bid response.

Processor shall furnish to Department of Education a surety bond obtained only from a surety company listed in the U.S. Department of Treasury Circular 570, "Surety Companies Acceptable on Federal Bonds", an irrevocable letter of credit, or an escrow account. Such bond, letter of credit, or escrow account shall be made payable to the Department of Education. The bond shall guarantee that the processor shall faithfully account for, return, or pay for all of the Commodity Food received or carried forward, in accordance with the processing agreement.

Inventory protection is required by the Department of Education prior to the delivery of commodity food to the processor. The minimum amount of the bond, letter or credit or escrow account, shall be determined by: value of the commodity food on order minus anticipated usage rate during the processing Agreement period. The bond shall remain in effect until all commodity food is properly accounted for, paid for or returned in accordance with the processing agreement. Liability for loss is provided in Article 18 of the processing agreement.

SPECIAL CONTRACT TERMS & CONDITIONS (Cont'd)

3. Quality Control/Total Quality Control: Prior to contract inception, the contractor shall submit to the Ohio Department of Education (ODE), Office for Child Nutrition (OCN) a narrative of the quality control or total quality control program at the processing plant. The narrative of the quality control or total quality control program is not to be submitted as part of the bid response.
4. Nutritional Analysis: As part of the bid response, the bidder should submit a nutritional analysis for all finished products proposed to be processed for the ODE, OCN.

Documentation listed above that is designated to be submitted with the bid response may also be requested during bid evaluation. Documents will be requested during evaluation and a deadline of seven (7) calendar days provided for submission. Failure to provide documents requested by the deadline provided will deem the bid not responsive.

PRODUCT SAMPLES:

A sample of product offered is required. A sample shall consist of two (2) cases each of Chicken Fajita Stromboli, Turkey Ham and Mozzarella Cheddar Cheese Stromboli and Ham(Pork) and Cheese Stromboli and must include instructions for cooking or preparation. Product samples shall meet all requirements as specified herein and shall bear required labeling and markings. Samples shall be certified by the processor's quality control department as meeting the specifications contained herein. Certification shall be in form of a letter on company letterhead, signed by authorized company representative.

Samples must be submitted prior to 1:00 pm on Friday, August 10, 2012 to the address shown below. Failure to submit samples as specified will result in the bidder being deemed as not responsive.

One (1) case of each product sample shall be used in sample evaluation and the other one (1) case shall be used to verify actual processed product received during the term of any contract issued pursuant to this bid. The samples may be analytically tested. Samples will not be returned. Failure to submit samples as specified will deem the bid not responsive. All samples must be accompanied by a USDA, AMS, Livestock & Seed Division grading certificate. The USDA certificate shall certify that the sample conforms to the specifications of this bid in the formulation and packaging. Samples submitted without a USDA, AMS, Livestock & Seed Division grading certificate will result in the bidder being deemed as not responsive.

EVALUATION: Bids will be evaluated in accordance with Article I-17 of the "Instructions, Terms and Conditions for Bidding". In addition, the bid will be evaluated according to the fee per pound for processing offered on the bid pricing page.

There will be a taste test of the samples submitted to determine acceptability. There will be, at a minimum, a ten (10) member panel composed of members of the Office for Child Nutrition staff, members of the ODE Commodity Advisory Board and /or students in Ohio. Samples will be evaluated for appearance, color, aroma, flavor (taste), and texture. If product sample is deemed unacceptable as a result of the taste test, no further consideration for award shall be given. If the product sample submitted for the taste test exceeds the specifications, as stated in the bid and is presented as being the end product for the entire contract, then the sample shall be the standard for the entire contract with anticipated yields as projected and costs as stated.

CONTRACT AWARD: The contract will be awarded to the lowest responsive and responsible bidder meeting all bid specifications and requirements. Low lot total will be determined by multiplying the unit price for each item by the minimum yield per truckload of raw commodity for that item and then multiplying that figure by the number of truckloads of raw commodity to be processed annually in order to obtain a line item extended price. The line item extended prices will be added to obtain a low lot total. Failure to bid on all items may result in the bidder being deemed non responsive.

USAGE REPORTS: Every six (6) months the contractor must submit a report (written or on disk) indicating sales generated by this contract. The report shall list usage by customer, by line item, showing the quantities/dollars generated by this contract. The report shall be forwarded to the Office of Procurement Services, 4200 Surface Road, Columbus, Ohio 43228-1395, Attn: Jennifer Shaefer.

## SPECIFICATION

### I. SCOPE AND CLASSIFICATION

#### A. Scope

The purpose of this bid is to obtain a contractor to process United States Department of Agriculture (USDA) commodity Reduced Fat, Shredded Cheddar Cheese, Chicken Fajita and Flour, into Fully Cooked, Chicken Fajita Stromboli; Mozzarella Cheese, Turkey Ham and Flour into Fully Cooked Turkey Ham and Cheese Stromboli; and American Cheese, Pork Ham and Flour into Ham and Cheese Stromboli for the Ohio Department of Education (ODE), Office for Child Nutrition (OCN). It is anticipated that about 20,000 lbs. of USDA Shredded Cheddar Cheese, 20,000 lbs. of Mozzarella Cheese, 20,000 lbs. of American Cheese, 20,000 lbs. of Chicken Fajita Strips, 20,000 lbs. of Turkey Ham, 30,000 lbs. of Pork Ham and 45,000 lbs. of Flour will be made available by the USDA to the state of Ohio annually to be processed under the ensuing contract. Quantities of raw products specified are based on anticipated product availability from the USDA. The state of Ohio is not obligated to request processing in these amounts or any other quantities. Commodities will be delivered to the contractor by the USDA and the contractor shall process product and deliver finished product to the three (3) cold storage facilities specified herein, or other facilities that ODE may enter into contract with for the provision of similar services. Bid pricing (price per pound of finished product) shall include all transportation charges for delivery of processed product to cold storage facilities, cost of USDA certification, and any other costs and charges associated with providing the specified product. The term of any contract issued pursuant to this bid shall be for three(3) years, from September 1, 2012 through August 31, 2015.

### II. REQUIREMENTS

#### A. USDA Commodity Description

2. USDA Mozzarella Cheese, Frozen, 8/6 lb., 840 cases or 40,320 lbs. per truckload, Material Code 100022 (B042)
3. USDA American Cheese Loaves, 6/5 lbs., 1320 cases or 38,400 lbs. per truckload, Material Code 100017 (B064)
4. USDA Chicken Fajita Strips, Frozen, 30 lb. cases or 39,000 lb. per truckload, Material Code 100117 (A563)
5. USDA Turkey Ham, Cooked, Frozen, 40 lb. cases or 40,000 lb. per truckload, Material Code 100126 (A548)
6. USDA Pork Ham, Frozen, 40 lb. cases or 40,000 lb. per truckload, Material Code 100184 (A693)
7. USDA All Purpose Enriched Flour, 50 lb. bags or 40,000 lbs. per truckload, Material Code 100399 (B190)

B. End Product Description

1. Chicken Fajita Stromboli, Fully Cooked, Individually Wrapped, Frozen

a. Formulation

<u>Ingredients</u>	<u>Percentage</u>
USDA commodity Cheddar Cheese	15.0% minimum
USDA Chicken Fajita Strips	29.00% maximum
USDA commodity Flour (100% whole grain, or over 50% of flour portion must be whole grain; the remaining flour portion must be enriched.)	31.00% maximum

Other Ingredients – seasonings, spices, etc.	11.00% maximum

- b. The fully cooked Stromboli shall be prepared using USDA commodity Cheddar Cheese, Chicken Fajita Strips, and Flour in accordance with the above formulation. The mixture shall be baked to a temperature of 106° F. Once baking is complete, product shall be wrapped in poly pouch bags and sealed without metal clips or ties. Product is to be quick chilled to 40° F. within 72 hours and frozen.
- c. The Chicken Fajita Stromboli shall be crusty on the outside and tender with chicken fajita strips, cheddar cheese, spices and seasonings on the inside. The Chicken Fajita Stromboli shall have an appealing odor and tasty flavor. There shall be no foreign odors or flavors such as, but not limited to burnt, moldy, scorched, stale, or rancid presentations.
- d. Product must not contain monosodium glutamate (MSG).
- e. Each fully cooked Chicken Fajita Stromboli shall have a net weight of 5.25 oz. +/- 0.1 oz. Each Stromboli shall provide 2.0 oz. equivalent Meat/Meat Alternate (M/MA) for the child nutrition meal pattern requirements and must not contain more than 105 mg of sodium per oz. of finished product.
- f. Product shall have a shelf life of at least nine (9) months if held frozen at 0 degrees F. or below.

2. Turkey Ham and Mozzarella Cheese Stromboli, Fully Cooked, Individually Wrapped, Frozen

The Pork Ham and American Cheese Stromboli shall have an appealing odor and tasty flavor. There shall be no foreign odors or flavors such as, but not limited to burnt, moldy, scorched, stale or rancid presentations.
- d. Product must not contain monosodium glutamate (MSG).
- e. Each fully cooked Pork Ham and American Cheese Stromboli shall have a net weight of 5.25 oz. +/- 0.1 oz. Each Stromboli shall provide 2.0 oz. equivalent Meat/Meat Alternate (M/MA) for the child nutrition meal pattern requirements and must not contain more than 170 mg of sodium per oz. of finished product.
- f. Product shall have a shelf life of at least nine (9) months if held frozen at zero degree F or below.

C. Preparation and Processing: All preparation and processing described herein shall occur subsequent to the date of award. The product shall be produced, processed, and stored in plants regularly operating under the supervision of the contractor.

F. Palletizing

Shipments shall be palletized according to standard industry practices and shall conform to the following:

1. Manufacturers standard 40" x 48" partial 4-way shipping pallets are acceptable.
2. Maximum Height: 7'6" (including pallet)
3. Maximum Weight: 3,500 lbs. (including pallet)
4. Pallets are to be securely banded or shrink wrapped.
