1. **Scope:** This Participating Addendum is governed by the PARCC Operational Assessment Price Agreement led by the State of New Mexico for use by PARCC Governing State agencies, authorized by the Governing State's statutes to utilize Cooperative Purchasing, Joint Purchasing, Sole Source, or similar statutory authority to contract with Contractor for services provided pursuant to the Price Agreement, with the prior approval of the state's chief procurement official.
2. **Participation:** Use of specific cooperative contracts by agencies, political subdivisions and other entities (including cooperatives) authorized by an individual state's statutes to use Governing State contracts are subject to the prior approval of the respective State Chief Procurement Official. Issues of interpretation and eligibility for participation are solely within the authority of the State Chief Procurement Official.
3. **State of Ohio Terms and Conditions:** The State of Ohio Standard Contract Terms and Conditions accessed via this link shall apply to all sales and services under this Participating Addendum.
4. **Entire Agreement:** The contract between Contractor and the PARCC Governing State shall consist of the following documents:

5. **Estimated Annual Student Testing Volume:** The Governing States shall provide Contractor with Testing Commitments by grade, subject, and mode of testing, on the form provided as Addendum Exhibit 1, incorporated herein.
6. **Annual State Total Contract Value:** Based upon the Estimated Annual Student Testing Volume, the Annual State Total Contract Value, as defined in SOW Attachment 3, is estimated to be \$26,062,774.00 for Contract Year 1. The total value of Optional Services elected herein is estimated at \$241,166.00 for Contract Year 1. Annual State Total Values for Contract Years 2-4 will be submitted to the Contractor on or before June 1 for each Contract Year here after. The Governing State shall make a monthly payment pursuant to the terms of SOW Attachment 4.
