SPECIAL CONTRACT COMPLIANCE AND TERMINATION.

During the term of this contract, the DSH Training Center Advisor responsible for your course shall be responsible for monitoring the Contractor's performance and compliance with the terms and conditions of the Contract. It is specifically understood that the nature of the services to be rendered pursuant to any contract resulting from this RFP are of such a nature that BWC is the sole judge of the adequacy of such services and will report them to DAS. DAS reserves the right to cancel the contract at any time without cause upon 14 days' notice. Upon cancellation, other than for the default of the Contractor, BWC shall pay the Contractor for services rendered prior to the effective date of the cancellation. If BWC's representative observes any infraction(s), such shall be documented and notice conveyed to DAS and then to the Contractor for immediate correction. Continued failures on the Contractor part to comply with the terms and conditions of the ensuing contract may constitute an event of default.

SPECIAL DEFAULT BY THE CONTRACTOR.

DAS declares and the Contractor acknowledges that BWC may suffer damages due to the failure of the Contractor to act in accordance with the requirements, terms and conditions of the contract. DAS declares and the Contractor agrees that such failure shall constitute an event of default on the part of the Contractor. The Contractor agrees that if DAS or BWC does not give prompt notice of such failure, that DAS and BWC has not waived any of its rights or remedies. In the event that a Contractor does not show up to teach a class, the Training Center Advisor responsible for the class will contact the Contractor to ascertain the reason for the missed class and then determine whether to reschedule the class. The contract with that Contractor might be terminated. Repeated late starts to a class might also be reason to terminate the Contract.
