WORK REQUIREMENTS AND SPECIAL PROVISIONS

COMPETITIVE SELECTION - TWO PHASE AWARD-QUOTE: This solicitation may be awarded to more than one Supplier of the same or similar types of supplies or services at varying prices for delivery within the same geographic area. If the contract is awarded to multiple Suppliers, providing the same supplies or services in the same geographic area, Ordering Agencies shall solicit quotes for the required supplies or services from multiple awarded Suppliers, prior to ordering.

The custodians over each building vary in their expertise in the fields of HVAC, Maintenance and Renovations, as well as Construction Services. The specifications thus will vary in detail, form, and submission. Any work performed without prior approval, will be at the Contractors' expense. Quotes should include: Estimated material list, estimated labor costs, an estimated project costs, and any additional items as requested by the facility representative.
