All Sign Language Interpreting Services provided by nationally certified interpreters. All Hallenross staff are licensed by the Ohio Department of Education. In the event that a certified or licensed interpreter is unavailable, services will be provided by a candidate for national certification (passed national written examination) or an individual determined by Hallenross to be otherwise qualified in accordance with the Americans with Disabilities Act of 1990. All Hallenross interpreters are able to provide services in American Sign Language and a variety of English based signing systems. Hallenross is also employs interpreters capable of working with individuals with low vision or need tactile sign language.
