
2. **Changes:** The purpose of this Amendment is as follows:

- b. The configuration limit of servers and storage is increased from \$300,000 to \$500,000.

The terms and conditions of this Addendum and the Price Agreement and its exhibits shall prevail and govern in the case of any such inconsistent or additional terms. This Addendum applies only in the jurisdiction of the Participating State or Participating Entity which has executed this Addendum.
