The Department of Administrative Services has accepted bids submitted in response to Invitation to Bid No. RS900818 that opened on 11/27/17. The evaluation of the bid response(s) has been completed. The bidder(s) listed herein have been determined to be the lowest responsive and responsible bidder(s) and have been awarded a contract for the items(s) listed. The respective bid response, including [the Terms and Conditions for Bidding, Standard Contract Terms and Conditions, and Supplemental Contract Terms and Conditions](#), special contract terms & conditions, any bid addenda, specifications, pricing schedules and any attachments incorporated by reference and accepted by DAS become a part of this Requirements Contract.

This Requirements Contract is effective beginning and ending on the dates noted above unless, prior to the expiration date, the Contract is renewed, terminated or cancelled in accordance with the Contract Terms and Conditions.

This Requirements Contract is available to all State Agencies, State institutions of higher education and properly registered members of the Cooperative Purchasing Program of the Department of Administrative Services, as applicable.

Agencies are eligible to make purchases of the listed supplies and/or services in any amount and at any time as determined by the agency. The State makes no representation or guarantee that agencies will purchase the volume of supplies and/or services as advertised in the Invitation to Bid.

SPECIAL NOTE: State agencies may make purchases under this Requirements Contract up to \$2500.00 using the state of Ohio payment card. Any purchase that exceeds \$2500.00 will be made using the official state of Ohio purchase order (ADM-0523). Any non-state agency, institution of higher education or Cooperative Purchasing member will use forms applicable to their respective agency.

SPECIAL CONTRACT TERMS AND CONDITIONS

AMENDMENTS TO CONTRACT TERMS AND CONDITIONS: The following Amendments to the Contract Terms and Conditions do hereby become a part hereof. In the event that an amendment conflicts with the Contract Terms and Conditions, the Amendment will prevail.

MULTIPLE AWARD CONTRACT: This bid is issued to establish a Multiple Award Contract (MAC). A MAC is a contract made with more than one supplier of the same or similar types of supplies or services at varying prices for delivery within the same geographic area. The state's obligations under a MAC are subject to the Ohio Controlling Board's continuing authorization to use the MAC program authorizing the use of Multiple Award Contracts.

DELIVERY AND ACCEPTANCE: Supplies will be delivered to the participating agency within 10 days after receipt of order and, in accordance with paragraphs S-8, S-9, and S-10 of the SUPPLEMENTAL CONTRACT TERMS AND CONDITIONS. The delivery location will be noted on the purchase order issued by the participating agency. Acceptance (transfer of title) will occur upon the inspection and written confirmation by the ordering agency that the supplies delivered conform to the requirements set forth in the Contract. Unless otherwise provided in the Contract, acceptance shall be conclusive except as regards to latent defects, fraud, or such gross mistakes as amount to fraud.

DESCRIPTIVE LITERATURE: The Bidder may be required to submit descriptive literature of the supplies or services being offered. If requested, the literature will be used in the evaluation process to determine the lowest responsive and responsible bidder. If not provided as part of the bid response, the Bidder must provide said literature within ten (10) calendar days after request/notification by the Office of Procurement Services to do so. Any references, that may appear in the descriptive literature, that may alter the terms and conditions and specifications of the bid (e.g. F.O.B. Shipping Point or Prices Subject to Change), will not be part of any contract and will be disregarded by the state of Ohio. Failure of the bidder to furnish descriptive literature either as part of their bid response or within the time specified herein will deem the bidder not responsive.

PRODUCT SAMPLES: The bidder(s) may be required to submit samples of the supplies being offered. The samples may be used in the evaluation process to determine lowest responsive and responsible bidder(s) per category. If not included as part of their bid response, the bidder may be required to provide the samples within ten (10) calendar days after notification. Failure to provide the samples within the stated time will result in the bidder being deemed not responsive. After award of the contract, the samples will be used as a basis of comparison with actual product delivered under contract. Any variation between the samples and product being delivered will be considered as an event of default. Any variations between the samples and actual product being delivered that are due to manufacturer changes may be acceptable and shall require prior written approval from Department of Administrative Services (DAS).

EVALUATION: Bids will be evaluated in accordance with Article I-17 of the "Instructions to Bidders". The state will evaluate bids based on Categories 1-8 listed within the bid document. In addition, the state will: multiply the Estimated Annual Usage listed in the bid for each line item by the Price per Unit of Measure arrive at the Line Item Total for that line item. DAS will calculate extended price by utilizing the following formula:

$$\text{Estimated Annual Usage} \times \text{Price per Unit of Measure (UOM)} = \text{Line Item Total}$$

Category totals will be determined by adding each of the items extended prices together in the same category.

CONTRACT AWARD: The contract will be awarded to the lowest responsive and responsible bidder(s) by product category. The State may award up to three (3) Bidders per category, as the State, in its sole decision, deems is in the its best interest of the State. Failure to bid all items in required Unit of Measure (UOM) may result in the bidder being deemed non-responsive. Failure to bid all items within a category may result in the bidder being deemed not responsive for that category. A bidder may receive an award for one or more categories.

FIXED-PRICE WITH ECONOMIC ADJUSTMENT: The contract prices(s) will remain firm for the first twelve (12) months duration of the contract. Thereafter, the Contractor may submit a request to increase their price(s) to be effective thirty (30) calendar days after acceptance by DAS. No price adjustment will be permitted prior to the effective date of the increase received by the Contractor from his suppliers, or on purchase orders that are already being processed, or on purchase orders that have been filled and are awaiting shipment. If the Contractor receives orders requiring quarterly delivery, the increase will apply to all deliveries made after the effective date of the price increase.

SPECIAL CONTRACT TERMS AND CONDITIONS (Cont'd.)

The price increase must be supported by a general price increase in the cost of the finished supplies, due to increases in the cost of raw materials, labor, freight, Workers' Compensation and/or Unemployment Insurance, etc. Detailed documentation, to include a comparison list of the contract items and proposed price increases, must be submitted to support the requested increase. Supportive documentation should include, but is not limited to: copies of the old and the current price lists or similar documents which indicate the original base cost of the product to the Contractor and the corresponding increase, and/or copies of correspondence sent by the Contractor's supplier on the supplier's letterhead, which contain the above price information and explains the source of the increase in such areas as raw materials, freight, fuel or labor, etc.

Should there be a decrease in the cost of the finished product due to a general decline in the market or some other factor, the Contractor is responsible to notify DAS immediately. The price decrease adjustment will be incorporated into the contract and will be effective on all purchase orders issued after the effective date of the decrease. If the price decrease is a temporary decrease, such should be noted on the invoice. If the temporary decrease is revoked, the contract pricing will be returned to the pricing in effect prior to the temporary decrease. For quarterly deliveries, any decrease will be applied to deliveries made after the effective date of the decrease. Failure to comply with this provision will be considered as a default and will be subject to Provision I.C. "Termination/Suspension" and Provision II. of the "Contract Remedies:" of the "Standard Contract Terms and Conditions".

PRICE LIST: For Item D, Discount off List Price, the bidder shall submit, as part of their bid response, a current price list(s) for other available products that are not included in the price page. Any references, that may appear on the price list(s) that may alter the terms and conditions and specifications of the bid (e.g. F.O.B. Shipping Point or Prices Subject to Change), will not be part of any contract and will be disregarded by the state of Ohio. Failure of the bidder to furnish a current price list(s) as part of their bid response may deem the bidder not responsive. If price list(s) are not provided with the bid submission the bidder will have seven (7) calendar days in which to provide them once they have been requested by the Office of Procurement Services. Failure to provide them within seven (7) calendar days may deem your bid not responsive.

During the life of the contract, there may be a new published price list. In this event, it will be necessary for the Contractor to supply the Office of Procurement Services with one (1) copy as applicable. Pricing contained in the new price list will become effective thirty (30) days after receipt and acceptance of notice by the Office of Procurement Services. Thereafter, state agencies may obtain the new price list from the Contractor.

USAGE REPORTS: Every six (6) months the contractor must submit a report (written or on disk) indicating sales generated by this contract. The report shall list usage by customer, by line item, showing the quantities/dollars generated by this contract. The report shall be forwarded to the Office of Procurement Services, 4200 Surface Road, Columbus, OH 43228-1395, Attn: Contract Analyst-Mary-Catherine Brown

COOPERATIVE PURCHASING CONTRACT. This Contract may be relied upon by Ohio institutions of higher education and Ohio political subdivisions. Ohio political subdivisions include any county, township, municipal corporation, school district, conservancy district, township park district, park district created under Chapter 1545 of the Revised Code, regional transit authority, regional airport authority, regional water and sewer district, port authority or any other political subdivision as described in the Ohio Revised Code. To qualify to use this Contract the political subdivision must be currently enrolled in the State's Cooperative Purchasing Program. Purchases made from this Contract by a political subdivision that is not properly registered with the State's Cooperative Purchasing Program will be a violation of law and may be contrary to the political subdivision's competitive bidding requirements. If a political subdivision or institution of higher education relies upon this Contract to issue a purchase order or other ordering document, the political subdivision or institution of higher education "steps into the shoes" of the State under this Contract. The political division's or institution of higher education's order and this Contract are between the Contractor and the political subdivision or institution of higher education. The Contractor must look solely to the political subdivision or institution of higher education for performance, including payment. The Contractor agrees to hold the state of Ohio harmless with regard to political subdivisions and institution of higher education's orders and political subdivision's and institution of higher education's performance. DAS may cancel this Contract and may seek remedies if the Contractor fails to honor its obligations under an order from a political subdivision or institution of higher education.

CONTRACTOR QUARTERLY SALES REPORT: The Contractor must report the quarterly dollar value (in U.S. dollars and rounded to the nearest whole dollar) of the sales, to include both state agencies and political subdivisions, under this Contract by calendar quarter (e.g. January-March, April-June, July-September and October-December). The dollar value of the sale is the price paid by the Contract user for the products and/or services listed on the purchase order or other encumbering document, as recorded by the Contractor.

SPECIAL CONTRACT TERMS AND CONDITIONS (Cont'd)

The Contractor will receive an email with a User ID and password and must report the quarterly dollar value of sales to the Department of Administrative Services (DAS) via the Internet using the web form at the Ohio DAS Contract Management Contractor Portal, <https://cm.ohio.gov/>. If no sales occur, the Contractor must show zero. The report must be submitted thirty (30) days following the completion of the reporting period. The Contractor is responsible for emailing the Analyst listed on page one of the contract with any company contact changes.

The Contractor shall also submit a close-out report within one hundred and twenty (120) days after the expiration of this Contract. The Contract expires upon the physical completion of the last outstanding task or delivery order of the Contract. The close-out report must cover all sales not shown in the final quarterly report and reconcile all errors and credits. If the

Contractor reported all contract sales and reconciled all errors and credits on the final quarterly report, then the Contractor should show zero "0" sales in the close-out report.

If the Contractor fails to submit sales reports, falsifies reports or fails to submit sales reports in a timely manner, DAS may suspend, terminate or cancel this Contract.

CONTRACTOR REVENUE SHARE: The Contractor must pay the Department of Administrative Services (DAS) a revenue share of the sales transacted under this contract. The Contractor must remit the revenue share in U.S. dollars within thirty (30) days after the end of the quarterly sales reporting period. The revenue share equals 0.75% of the total quarterly sales reported. Contractors must include the revenue share in their prices. The revenue share is included in the award price(s) and reflected in the total amount charged to ordering agencies which includes both state agencies and political subdivisions using this Contract.

The contractor must remit any monies due as the result of the close-out report at the time the close-out report is submitted to DAS. The Contractor must pay the revenue share amount due by check. To ensure the payment is credited properly, the Contractor must identify the check as a "Revenue Share" and include the Ohio Contract Management Remittance Report

If the full amount of the revenue share is not paid within thirty (30) calendar days after the end of the applicable reporting period, the non-payment constitutes a contract debt to the State. The State may either initiate withholding or setting off payments or employ the remedies available under Ohio law for the non-payment of the revenue share.

If the Contractor fails to pay the revenue share in a timely manner, DAS may suspend, terminate or cancel this Contract.

GENERAL SPECIFICATIONS

I. SCOPE

These specifications include agricultural and specialized fertilizers, fertilizer materials, pesticides, fungicides, herbicides and other related chemicals listed in the bid. This contract is available to all participating agencies listed herein (Customers).

II. GENERAL REQUIREMENTS

A. Definitions:

1. Granular – A dust free “manufactured” fertilizer or pesticide, in which each granule has nearly homogenized composition and particle size is nearly uniform.
2. Liquid – A free flowing fluid mixture of fertilizer, fertilizer materials, or pesticide.
3. Water-soluble packet – A dry pesticide contained within a water-soluble film packet.
4. Tablet – A dry pesticide in tablet form, for applying to soil.

B. Product Categories: The bid consist of eight (8) different product categories. See the listing and their examples in the table below.

C. Product Type: Manufacturers' names, trade names, brand names or catalog numbers are used only for description and to establish a market reference of the acceptable quality sought by the state. Other brand names or generic equivalent found to be of equal or better quality will be considered. Primary consideration for product equivalent, is the required active ingredient. Determination will be made at the sole discretion of the State of Ohio DAS.

D. Workmanship: All agricultural chemicals offered shall meet or exceed given specifications and shall be clean, uniform and free from any defects which may impair their utility. All products herein shall conform to current acceptable industry standards and be of highest quality. Products shall be manufactured and handled in accordance with good, generally accepted industry practices.

1. All material offered as a result of a contract award shall meet the requirements as set forth by the Ohio Fertilizer Law, Fed. Specification O-F-241D and the latest revisions thereof.
2. The labeling, weighing and selling of agricultural fertilizers and fertilizing materials shall be in accordance with the Ohio Regulations governing the activities.
3. Only industry standard fillers or conditioners shall be used, like limestone, sand, corncob, dolomite, etc. Usage of “chert” as a filler is not acceptable and will be returned at the contractor’s expense.
4. Primary components of fertilizer shall not vary more than + 2.0% (for each component). Ratio difference shall not be more than 0.5% of what is specified in this bid. For example, a 10-20-20 analysis may vary from 8 to 12 parts N, 18 to 22 parts P and/or K, as long as the total difference did not exceed 95% (i.e., the 10-20-20 could vary to 10-19-18.5).

None of the above described products are to be manufactured from reclaimed, re-refined, recycled, used, or otherwise not new ingredients. All components, elements, and ingredients of these items must be newly derived from their natural or chemical resources, and must have been manufactured within one (1) year of their day of shipment to the agency.

GENERAL SPECIFICATIONS (Cont'd)

- E. Material Safety Data Sheets: "Material Safety Data Sheets" shall be sent at the time of the shipment, and/or upon request by the buyer, by the contractor, with all initial shipments going to various destinations as ordered after the award of the contract. If, applicable, the MSDS shall verify the Contractor's compliance with the OSHA Hazard Communication Standard 29 CFR 1910.1200. If the chemical composition of the compound being bid does not contain any hazardous effect, the contractor must indicate so on the "Material Safety Data Sheet".
- F. Finished Goods Material Safety Data Sheets and Label: For all items awarded that are in ready to ship in package form or concentrate form, approved MSDS and labels will be provided as required or as requested.
- G. Packaging and Handling: The handling, packaging, labeling, recording, and registration of all chemicals and contract related materials shall comply with all applicable Federal, state, and local laws and regulations. The product(s) shall be in containers to assure carrier acceptance and safe arrival in accordance with paragraphs S-8, S-9, and S-10 and the SUPPLEMENTAL CONTRACT TERMS AND CONDITIONS, unless otherwise specified by the participating agency, for such supplies. Containers shall be in compliance with Uniform Freight Classification or National Motor Freight Classification and/or Department of Transportation, as applicable.
1. Product Handling (Leakage/Spillage): All products purchased in bags, bottles, buckets, cases, packets and other containers shall conform to industry standards and must be leak proof. If upon delivery, the product package is leaking material, the contractor has responsibility to address any spills and if necessary replace product content and package.
 2. Marking: In addition to any special marking required by the contract or purchase order, interior packages and shipping containers shall be marked in accordance with governing authorities' rules and regulations. All chemicals requiring precautionary measures shall be so marked as required by law and/or shipping regulations. All packages shall be marked to indicate either the expiration date or the date of manufacture, unless product has no expiration. If date coded, the Contractor shall provide institution contact with the appropriate code key(s) for all products as necessary.
 3. Labelling: Product package labels must be of a type that is standard in the industry. The label on each container shall show the following, as a minimum:
 - a. The name and address of the manufacturer.
 - b. The name of the product, including brand name, if any.
 - c. An active ingredient statement, as required for EPA registration.
 - d. The manufacturer's directions for use, in detail, including the manufacturer's use-dilution statement to perform as outlined in this specification, as applicable.
 - e. Label shall state that product contains active organisms, if applicable.
 - f. EPA Registration Number and Establishment Number, if any.
 - g. Any warning statement, as may be applicable to the product, concerning skin irritancy, toxicity, or potential hazard and immediate first aid treatment in case of accident, as required by EPA.
 - h. Net contents, in U.S. liquid measure.
 - i. Batch number, as applicable.
 - j. Expiration date.
 - k. Recommended dilution ratio, as applicable.
- H. Poison Control: All the chemicals as stated herein, should be on file with an Ohio Poison Control Center, certified by the American Association of Poison Control so that all data necessary for prompt and correct treatment of accident victims may be available at a local Poison Control Center for immediate use on a twenty-four (24) hour basis if required.
- I. Shipping: For All products purchased in bulk, the loading and shipping must conform to the applicable carrier rules and regulations. Orders written against this contract may be for full drum and may be for less than full case and pallet quantities. Shipment is to be made by freight, parcel post, express or commercial package delivery, whichever is the most economical method for proper delivery of the item, F.O.B. destination. Participating agencies may request special delivery methods. The cost of transportation from the vendor's address to the destination on such orders shall be added to the invoice.
1. For minimum orders, the minimum dollar value of any order placed against a contract, awarded pursuant to this Bid, for delivery F.O.B. destination, transportation charges prepaid, at any one time to one destination, shall be not less than fifty (\$50.00) dollars. Refer to paragraphs S-8, S-9, and S-10 of the SUPPLEMENTAL CONTRACT TERMS AND CONDITIONS.

GENERAL SPECIFICATIONS (Cont'd)

J. General Quality Verification through Inspection and Test Procedures:

1. The state reserves the right to check the delivery of any bulk or liquid product on the nearest certified weighing scale.
2. Samples may be taken at any time from deliveries made during the contract period and tested for compliance to the specifications.
3. Sampling and testing is to be done in accordance with procedures from the Ohio Department of Agriculture, the Ohio Department of Natural Resources, the Ohio Department of Transportation, Ohio Department of Rehabilitation and Correction and any other DAS Cooperative buyer.
4. If the product does not meet specifications or fails testing, the contractor will be responsible for testing costs and costs associated with product replacement.

K. Licensing Requirements -All vendors must be licensed to manufacture or distribute agricultural fertilizer and chemicals (pesticides, fungicides, insecticides and herbicides) in the state of Ohio. All bidders/contractors must have a current license, from the Ohio Department of Agriculture, to sell fertilizers and pesticides. A copy of the fertilizer and pesticide licenses must be provided with the Bid. Failure to provide licenses as specified may result in the Bidder being deemed as non-responsive and the Bid response may be immediately disqualified with no further consideration given for potential awarding of the Contract.

The Contractor must maintain all licenses throughout the term of this contract and any renewals. At the request of a State Agency, a copy shall be provided within five (5) calendar days. Failure to maintain and provide copies of license(s) when requested may result in cancellation of the Contract.
